## J.S. II - <u>John Nance</u> (died 1716 Prince George, Va.) md. <u>Sarah</u> (Gookings or Soakings)

See 1716 will. Ages of children and various and sundry items concerning one of the married daughters indicates John Nance was born about 1660. Richard appears to be the oldest eon. The will names he and wife Sarah as co-executors. The mention of Mother Gookings or Sookings estate indicates there are entailed lands which, by English law, automatically became the property of the oldest son upon his mother's death. Son John appears to have received the bulk of his father's estate. The writer has done some research looking for the Sookings family of Virginia to no avail. But there was a Gookings family of Virginia, quite prominent. Additional research may reveal such a Nance-Gookings relationship.
