John died without a will. Lived in Lunenburg, Amelia, and Pittsylvania Cos, Virginia. His widow, Mrtha, was still on the Pittaylvania County tax records until 1784.

ABSTRACT OF WILL OF GILES NANCE

Written 5 November 1809. Probated Wake County, N.C., February Court, 1811. wife:—Mary received mansion house and plantation household goods; six Negroes - Joe, Tabb (f), Ede (f), Frank, Suzy, George; two horses, all the cattle and hogs.

son Frederick received one negro, Betty,
daughter Cloa Mitchell received one negro named Cloe (already in her possession).

daughter Mary Young received one negro, Jerry.

son Clement received 300 acres of land more or less, lying on waters of Sugar Creek in Pittsylvania County, Virginia. Also a negro boy, Armatead.

son Robert received a negro woman, Arney, and her son, Alex.

son Giles received plantation (at mother's death), livestock and a shot gun (his choice).

At his wife's death, the remainder of the estate to be sold end equally divided between all of his children, namely: 1) Cloa Mitchell, 2) William M., 3) James, 4) Mary Young, 5) Elizabeth Crenshaw, 6) Frederick, 7) Clement, 8) Robert, and 9) Giles,
