DANIEL SHAKELFORD WILL, 1851, PLATTE COUNTY, MISSOURI

In the name of God Amen,

I Daniel Shackelford of the County of Platte and State of Missouri
 being poorly of body but of perfect mind and memory do ordain this the fol-
 lowing disposal of all my worldly goods both real and personal to be my last
 will and testament.

I give and bequeath all my worldly goods personal and real estate to
 my wife Tabitha during her life to support her and after all just debts are
 paid, it is my will and wish that James G, Williams after my death shall
 take my negro boy Jack and my land on which I now reside and the balance of
 my property and manage it for my wife Tabitha and after her death for the
 property left to be equally divided between Amy Wills, Nancy Olifant's chil-
 dren James Olifant, Mary Gideon, Jasper Olifant, Newton Olifant, Manerva Oli-
 fant, Susan Sercey, Reuben Shackelford's children Elizabeth Nance, James
 Shackelford, John Shackelford, William Shackelford, Irene Stiles, Tabitha
 Shackelford, Reuben Shackelford, Samuel Shackelford, Sally Wills, Polley Wil-
 liams,

It is also my will and wish that Susan Bryan (?) shall have five dol-
 lars of my estate after the death of my wife Tabitha.
