Gen. L.O. VI - Lessenby Nance (b.20 Aug.1801, Henry Co,, Va,) 1st md, Oney P. Simms daughter of Jane "Nance" and Ignatious Simms and a second cousin. Moved from Henry Co. about 1830, was in Ky. House of Representatives 1836 and 1840, Was in 1840 and 1850 Trigg Co. Census. 1850 Census shows his wife as Mary L., age 33, bn, Va.
