1722 - June 22, Richard Nance, of Prince George County, 142 acres on south side Gravelly Run on both sides of the Great Branch, in Prince George County, (No. 11. p. 119.)

1731 - June 26, John Nance, of Prince George County, 252 acres on the north side of Hatcher's Run, adjoining his old land south side of Picture Branch. (No 14, p. 161)

1733 - June 20, Daniel Nance, junior of Prince George County, 200 acres on both sides of Picture Branch adjoining upper line of John Nance on the north side of Picture Branch (No. 15, p, 88)

1743 - June 30, Richard Nance, 184 acres Prince George County, south side Gravilly Run adjoining his own land, Francis Epee, Thos. Gent, Jr., and Captain Francis Eppes (No. 21, p. 420)
