Gen. E.L. VII - Ezekiel Edward Nance (6.12 Sept.1816, Ark. - d.15 Sept.1885 Kyle, Tex.) 1st md. 22 Mar.1840, Hempstead, Ark. Luaney Weightsell Pate (b. 2 Mar.1824 - d.22 Feb.1852), daughter of Jerimiah and Sarah Pate, 2nd md. 7 Apr.1853, Hempstead Co., Martha Alexander. Moved to Hayes Co., Texas, 1852/3. Children by first marriage were born in Hempstead, Ark., those by second marriage were born in Hayes Co., Tex.

Ezekiel Nance was an early industrialist in Texas. He built a cotton gin, wood work mill, grist mill, and meat packing plant, and furnished meat to the Confederate army. He was a farmer and rancher and built a home in 1853/55 which still stands and is occupied by his granddaughter, Mrs. Laverne Allen. Built the Ezekiel Nance Chapel in 1865 which is still standing and is being restored as a monument to a great Texan. About half of his 14,000 acre cattle ranch is still owned and operated by his grand children.
