John - Henry Co. Militia (not listed in Gathaways) he was listed as a member of Peter Hairston's Co. ordered to the assistance of General Greene March 1781. (from Va. *M.* of History Vol. 17, p. 191)

Military Land Grants to Nances of the Revolution

Robert - 4000 acres Kentucky for three years service as Captain in the Va. line July 17, 1783, Warrant No, 850.

Frederick - 200 acres for three years service as a sergeant in the Va. Continental line March 23, 1784 War. No. 3008,

Zachariah - 200 acres for three years service in Va, Line. War. No. 3114.

Revolutionary Pension Declarations

1832 - Frederick: Born Feb. 1761 in Lunenburg Co., Va., moved in the Fall of 1801 to Washington Co., Ky. Maria Crosby. Died July 14, 1835. Service: December 1776-November 6, 1781. He was pensioned on cert. #25 171. His widow was pensioned on Cert. # 3 492. Widow received 160 acres Warr. # 14 505.. Case No, W 186 HL wt 14 505-160-55.

1832 - James: An, 1762 (Feb. 2) Amelia Co. (now Nottoway). Moved to Wake Co. Jan. 5, 1801, Service: Feb. 9, 1779 to end of war.

1832 - William M. - age 72, bn. January 18, 1760, Amelia Co. (now Nottoway). Moved to Pittsylvania December 1780. Service: Substitute for William Mitchell at Amelia, (no other information)

1832 - Sherwood - age 78, a resident of Union S.C., born October 17, 1754 in Charlotte Co., Va. Moved to Caswell Co. N.C, when he went into service January 1775. Served to 1781, File No. S 21 394.

1833 - Zachariah, age 72, enlisted February 17, 1777, at Williamsburg, Va from New Kent Co. Served until 1880 at which time he was discharged. Now living at Sangamon Co., Ill. File No, S 31 272.

1852 - Peter, age 90, substituted for his brother John who returned home sick in 1780, Served with troops in Camden, S.C., his then residence. Didn't know that he was entitled to pension, being substitute. File R. 7 553.
