David Nance, wife Mary Crenshaw, his parents uncertain. In the NM his father was thought to be William How, but not certain. John and Jane Nance had a son William, bn. 1728. David md. Mary Crenshaw in 1769, The age certainly coincides. The William lived in the same area; however very lit⁻ tle information has been found.

Giles Nance deeded land to David and William H. Nance, orphan eons of David Nance, deceased, 1796, for love and affection. Doubtless there was a very close family relationship here. Giles would be much to young to be father of David, but could have been a brother (?). In this case David's father would have been John Nance Jr., wife Martha, brother to above mentioned William (b.1728). This writer is inclined to believe that David is the son of William Nance, son of John and Jane.

Ref. NM says David is a Revolutionary Soldier. No records of Service. Pittsylvania, Va. Bk. #4, p.41, 23 Oct.1777, David and Buckner Nance brought into court and charged with being enemies to the Commonwealth and charged to keep the peace.

Bk. #4, p.285, 22 Jan.1780 - Robert Bullington found guilty of having stabbed and killed David Nance.
