

Item 9, I given unto my daughter Morning Pope my Tract of land lying upon Meherrin river on the north side unto her and her heirs forever, also three cows and calves, etc.

Item 10, son Thomas Pope my plantation on the south side of Mar-rattock river,..

Item 11.... son Samuel Pope my part of a tract of land which I suppose to be 300 acres...made over to him that is in my son John Popes name patented... also my will that if either of my three younger sons die without heir that the others may have all his part.

Item 12. ...Mary Clother 1 cow and calf at her freedom from my wife.

Item 13. I also leave unto my son John Pope my part of the stock of cattle which is in his hands now provided he will pay his Tobacco that I am bound for and have in possession for my cousin Edward and John Pope and if he shall refuse then to turn the cattle into my estate.

Item 14. I give and ..my beloved wife Sarah Pope all the rest of my estate both out Doors and in Doors to her behoof, and I appoint her and my eon John Pope my whole and sole Executor and Executrix...28 May 1728. Recorded 28 Oct,1728. - - - - -

William, Jacob, John and Thomas Pope patented lands in 1723 and 1728, on South side of Morrattuck River. (Land Book 3, pp. 179, 163, and 232)

John Pope, b.circa 1699; d. intestate, in Edgecombe Co., N.C. in 1746; m. Mourning McKinnie, d.between 1741 and 1763, daughter of Col. Barnaby McKinnie Sr. 1673 - 1740, and his 1st wife Mary. John Pope was Justice of the Peace for and within Edgecombe Precinct Chowan Co., 16 May 1732 (C.R.N.C., Vol. 3, p.417); on 6 Mar.1739, was appointed commissioner of Peace with Barnaby McKinnie, et. al. (C.R.N.C., Vol. 4, p.346); was a Church Warden for Bertie Co. prior to 1740

and Edgecombe Feb.26, 1739-40 2(C,R,N)C., Vol.4,p.521); member the GGeneral¹⁰ Assembly from Edgecombe 15 Mar.1742, 22 July1743, 24 Feb.1743-4, 15 Nov.1744, 9 Apr.1746 (C.R.N.C.,Vol.4, pp.621-2, 723, 774). On 9 Apr.1746 Mr. James Castellaw reported to the General Assembly (House of Burgesses) that John Pope one of the members from Edgecombe was dead (C.R.N.C.,Vol.4, p.744)

Deed from Henry Pope of Isle of Wight Co., Va. to his son John Pope of Bertie Co., N.C. (Bertie Co. Book B, p.107), 1726. Deed from John to his father Henry (Bertie Co. Book A, p.162), 16 Aug.1722.

1729 - John and Mourning Pepe sell William Bennett 200 acres of land patented by John Pope in 1728. (Book "C", p.136, Bertie Co.)

1741 - Aug.19, John Pope sells 200 acres to John Pope(no doubt his son) Ed-gecombe Co. (Halifax Co. Deed Book 1, p.396)

1741, Aug.18 - John and Mourni Pope deed 200 acres to Aaron Etheridge of Va. (Halifax Co. Deed Book 1, p.398)

1734 - 10 Jan. John Pope deeds 200 acres to William Kinchen. Craven Co., N.C. (Newbern) Deed Book 2, p.382. - - - - -

John Pope, son of John and Mourning Pope, was appointed Commissioner of the Peace of Edgecombe Co. on 27 June 1746 (C.R.N.C., Vol.4, p.812), Justice of the Peace, Edgecombe Co., on 11 Oct.1749 (Ibid, p.966) and Sheriff of Edgecombe Co. for the years 1763-1755 (C.R.N.C., Vol.6, p.211).
